

Terms & Conditions

The Collaborative Exchange (Pty) Ltd, (“the Company”), is an event management company which has been contracted to organise and manage the Luno Institutional Digital Asset Conference (LIDAC) 2026 event (“the event”) on behalf of the Luno (Pty) Ltd. Any person who registers or is registered to attend or attends the event is referred to as a (“Delegate”).

The following terms and conditions, which include our Privacy Policy, collectively, the (“Terms of Use), govern the relationship between Delegate(s), the Company, Luno (Pty) Ltd and their affiliates and subsidiaries and sets out the terms on which a Delegate may use and access the registration for the Event (including any sub-domains, platforms or pages thereof).

By accessing or using the website and/or registering for the Event as a Delegate, you agree to comply with these Terms of Use, and acknowledge and consent to be bound by the terms of our Privacy Policy.

Registration, Cancellation and Amendments:

In cases where payment is required:

- Card transactions will be acquired for the Company via PayGate (Pty) Ltd who are the approved payment gateway for all South African acquiring banks. PayGate uses the strictest form of encryption, namely Secure Socket Layer

The merchant outlet country at the time of presenting payment options to the cardholder is South Africa. Transaction currency is South African Rand (ZAR).
